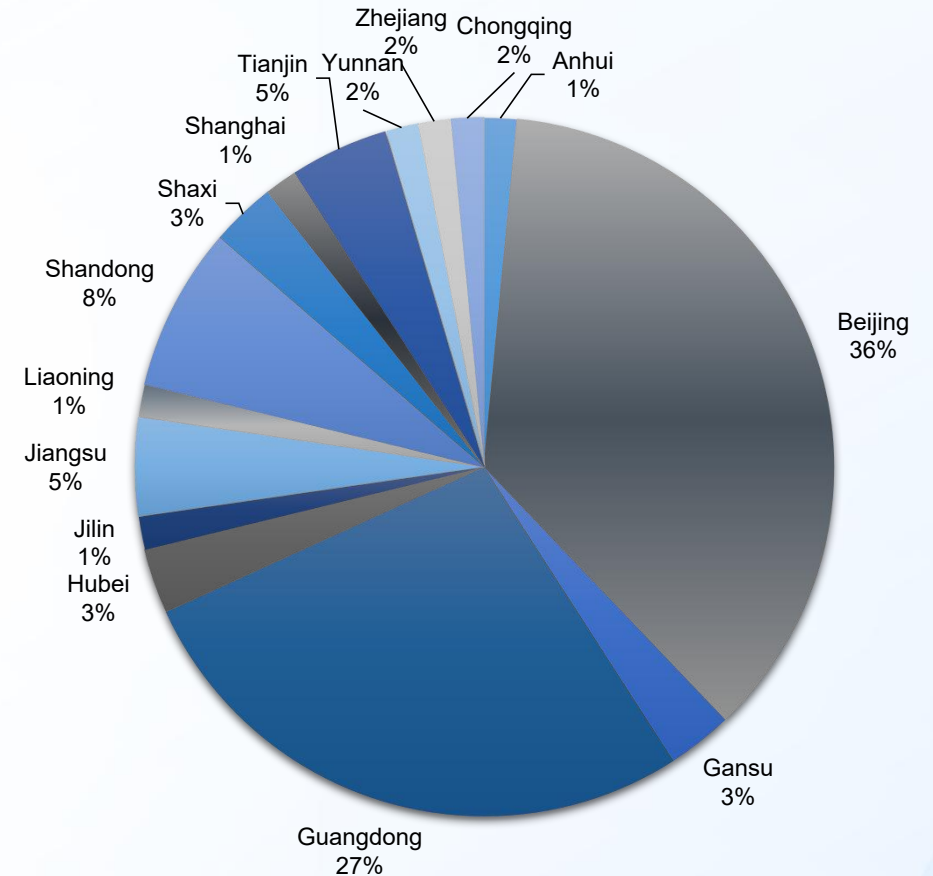

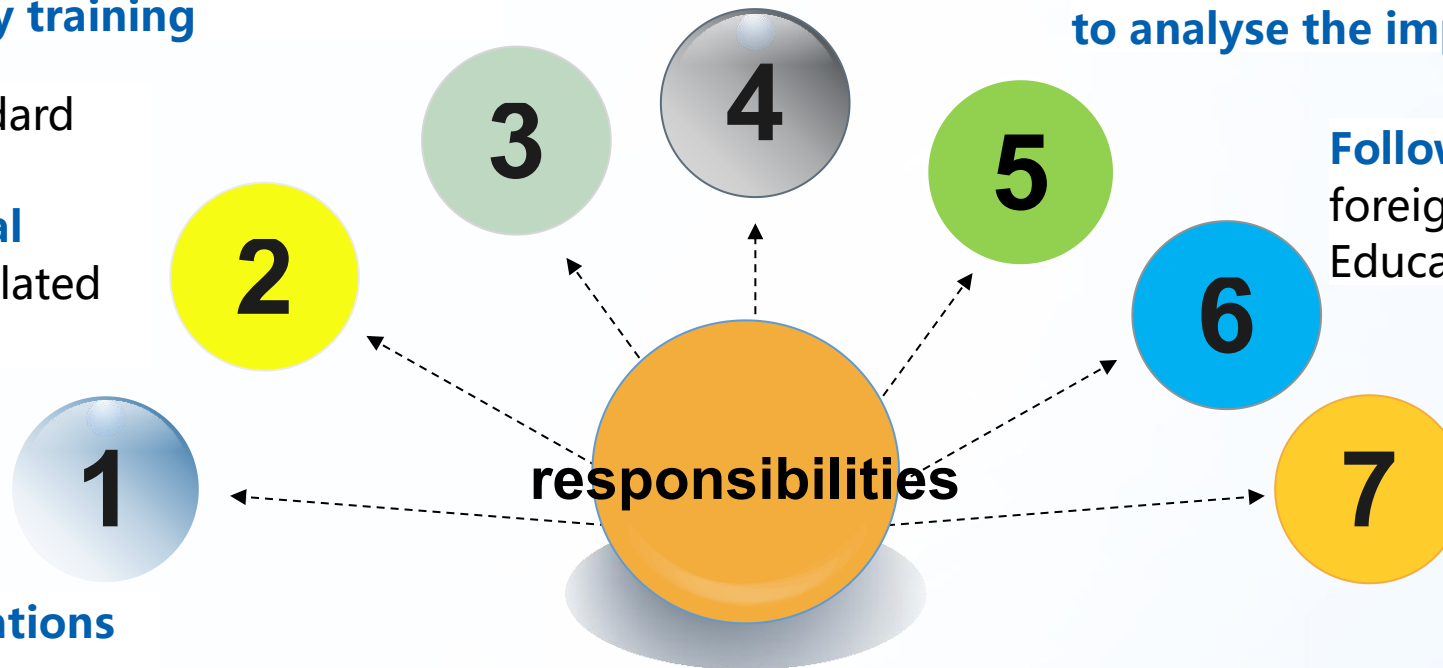
Interpret, publicize and implement the established national standards and provide necessary training

Follow and study domestic and foreign practical experience in Education about Standardization

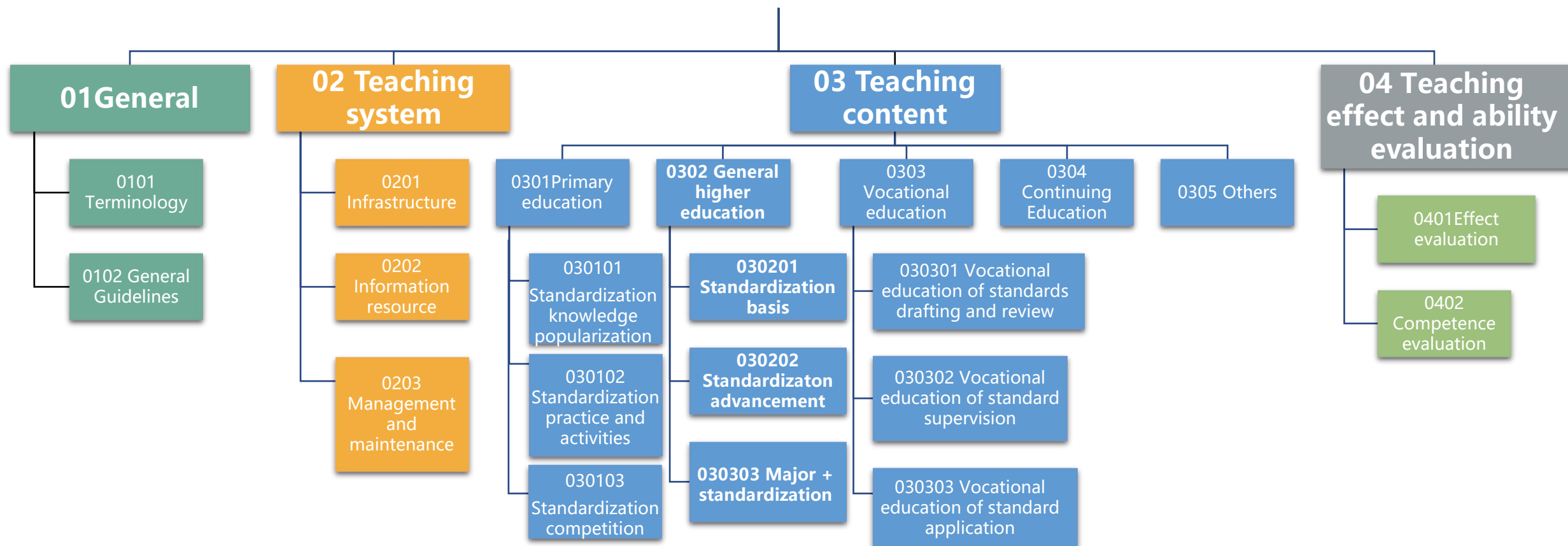
Responsible for the standardization review of projects introduced to this field and submit a analysis report of standardization level
